## **Terms and Conditions**

### **Proof of Identity**

Photo identification must be provided on the day of hire (without exception). Accepted forms of I.D. are UK Driving License or Passport, photo ID from employer etc. This will be kept (or copies) and stored securely for the duration of the hire and will be issued back to the client upon return of the equipment in a satisfactory condition.

### **Damage Deposit and Liability**

The person signing the Hire Agreement Form will be held financially liable for any loss or damage to the equipment hired. The hirer agreed to inspect the bicycle(s) prior to signing the agreement and to confirm that they are in a satisfactory state and safe and fit for purpose. The hirer agrees to fully indemnify MDCT against injury to anyone within the hirer's party, members of the public and any damage to property.

### **Security and Safety**

As the client, you understand that you are responsible for all equipment relating to this agreement. This means that you the client should take care to lock the bike to a fixed object through the frame and front wheel whenever unattended using the lock provided. Helmets are offered to all hirers and MDCT strongly recommend everyone wears a helmet. Children under 14 years are not allowed to use an eBike. The adult is responsible for the children in his/her care and in the unlikely event of an accident involving the child (ren), the adult acknowledges that MDCT will not be liable for any direct or indirect loss, damage or injury arising from or in connection with the activities. As the client, you understand that any cycling activity involves a certain element of risk; you are advised that any person using MDCT equipment does so entirely at their own risk. MDCT does not accept any liability for personal injury, loss or damage to property beyond its legal obligations.

### **Cycling Manner**

The hirer agrees to cycle sensibly with respect for others and the natural habitat. They are expected to follow the Highway Code. Anyone cycling in a discourteous or unsafe manner while in possession of MDCT equipment will have the equipment repossessed without refund or hire charges.

### **User Survey**
